GRANT OF OPTIONS AND GRANT OF SHARE UNITS

This announcement is made pursuant to Rule 17.06A of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

Grant of options

The Company’s board (the “**Board**”) of directors (“**Directors**”) announces that on 20 August 2021 (the “**Grant Date**”), it has granted 6,233,000 share options (the “**Options**”) to certain eligible participants of the Scheme (as defined below) (the “**Option Grantees**” and each an “**Option Grantee**”) who are non-executive Directors or employees of the Group, subject to acceptance by the Option Grantees, to subscribe for a total of 6,233,000 ordinary shares of the Company (the “**Shares**” and each a “**Share**”) pursuant to the 2019 share option scheme of the Company adopted on 19 August 2019 and approved by shareholders of the Company on 27 November 2019 (the “**Scheme**”).

A summary of the terms of the Options granted is set out below:

Grant Date: 20 August 2021

Exercise price of Options granted: HK\$9.37 per Share, which is the highest among

- (i) the closing price of HK\$8.98 per Share as stated in the daily quotation sheets issued by the Stock Exchange on the Grant Date;
- (ii) the average closing price of HK\$9.37 per Share as stated in the daily quotation sheets issued by the Stock Exchange for the five trading days immediately preceding the Grant Date; and
- (iii) the nominal value of each Share.

Pursuant to Rule 17.04(1) of the Listing Rules, the above grant of Options to Mr. Qian Jiannong, Mr. Xu Bingbin, Mr. Choi Yin On, Mr. Xu Xiaoliang and Mr. Pan Donghui was approved by the independent non-executive Directors on 20 August 2021.

Save as disclosed above, none of the grantees of the Options is a Director, chief executive or substantial shareholder of the Company or an associate of any of them.

Grant of share units

The Board has granted 3,146,000 share units to certain eligible participants (the “**Unit Grantees**” and each a “**Unit Grantee**”) of the Plan (as defined below) who are non-executive Directors or employees of the Group, subject to acceptance by the Unit Grantees, to subscribe for a total of 3,146,000 Shares pursuant to the 2019 share award plan of the Company adopted on 19 August 2019 (as amended) (the “**Plan**”).

A summary of the terms of the share units granted is set out below:

As set out in the Company's announcement dated 19 August 2019, the grant of share units to the above Directors, which forms part of their remuneration under their service contract, is fully exempt from the reporting, announcement and independent shareholders' approval requirements under Rules 14A.73(6) and 14A.95 of the Listing Rules.

The Board has resolved to allot and issue a total of not more than 3,146,000 new Shares to satisfy above grant of share units, which shall be made pursuant to the general mandate ("**General Mandate**") granted by the shareholders of the Company to the Directors to allot, issue and otherwise deal with new Shares at the annual general meeting of the Company held on 20 May 2021 (the "**AGM**").

Assuming that a total of not more than 3,146,000 new Shares are to be allotted and issued by the Company, such new Shares shall represent (i) approximately 0.2542% of the total number of Shares in issue as at the date of this announcement; and (ii) approximately 0.2535% of the total number of Shares as enlarged by the proposed issue (assuming there is no change in the total number of Shares in issue from the date of this announcement up to the date of such issue). No funds will be raised as a result of the aforesaid proposed issue of new Shares.

Pursuant to the General Mandate, the Company is authorized to allot and issue up to 247,240,485 Shares, representing approximately 20% of the total number of Shares in issue as at the date of the AGM. As at the date of this announcement, 2,060,969 Shares

have been allotted and issued under the General Mandate. Accordingly, the maximum number of new Shares which may be issued by the Company under the General Mandate is 245,179,516 Shares, representing approximately 19.83% of the total number of Shares in issue as at the date of the AGM.

Application will be made by the Company to the Stock Exchange for the listing of, and permission to deal in, a total of not more than 3,146,000 new Shares.

The Company has not conducted any equity fundraising activities in the past 12 months immediately preceding the date of this announcement.

The new Shares, when issued and fully paid, shall rank *pari passu* among themselves and with the other Shares in issue, with rights to receive all dividends and other distributions declared, made or paid on or after the date of allotment or issue.
